# THIS LESSON PLAN FOCUSES ON:

FOUNDATION

Activist Helen Zia who was involved in advocating for the Vincent Chin civil rights case in the 1980s. She is a successful journalist, serving as executive editor for Ms. magazine. She was a witness in the court case Perry v. Schwarzenegger which legalized same-sex marriage in California. She is also an author and public speaker.

	-There is a short video available about the Vincent Chin case, told by Asian-Americans. The instructor can choose to show the video to explain the Vincent Chin case or use the available resources to explain the case themselves.
